# Terms and Conditions of the "Autumn Promotion"

### 1. General Provisions

- 1.1. The organizer of the "Autumn Promotion" (hereinafter referred to as the "Promotion") is **BIURO RACHUNKOWE "JMJ" S.C. JADWIGA LEŚ-MALEC, JACEK NOGIEĆ**, with its registered office at ul. Rydlówka 42a/2, 30-363 Kraków, Poland, NIP: 6772176541, REGON: 356319906 (hereinafter referred to as the "Organizer").
- 1.2. The Promotion is valid from **November 11, 2025, until January 31, 2026**, unless the Organizer decides to end it earlier or extend it.
- 1.3. These Terms and Conditions define the rules, eligibility criteria, and conditions for granting discounts within the Promotion.

# 2. Eligibility

- 2.1. The Promotion is open to any natural person, legal entity, or organizational unit without legal personality that signs an agreement for accounting services with the Organizer during the Promotion period.
- 2.2. The Promotion applies to new clients as well as current clients who refer new clients to the Organizer.
- 2.3. Participation in the Promotion is voluntary and does not require the purchase of any additional services beyond those covered by the Promotion.

#### 3. Discount Rules

### 3.1. New Clients

Any client who signs an agreement for accounting services with the Organizer between **November 11, 2025, and January 31, 2026**, will receive a discount for a period of **3 months**, as follows:

- 30% off for keeping the tax revenue and expense ledger or income records,
- 30% off for full accounting services.

## 3.2. Referring Clients

Each current client of the Organizer who refers a new client that signs an agreement for accounting services will receive a discount for a period of **3 months**, as follows:

- 20% off for keeping the tax revenue and expense ledger or income records,
- 20% off for full accounting services.

#### 3.3.

The discount applies for a period of 3 months, starting from the date the Organizer begins providing accounting services under the signed agreement.

The discount will be granted in the form of a reduction in the value of the invoice for the provided accounting services.

### 4. Limitations

- 4.1. The Promotion cannot be combined with other promotions organized by the Organizer.
- 4.2. The Promotion applies only to agreements signed during the Promotion period.
- 4.3. Discounts granted under the Promotion cannot be exchanged for cash or transferred to another person.

# 5. Complaints

- 5.1. Participants of the Promotion have the right to submit complaints regarding the validity of the granted discount within 14 days from the date of receiving the invoice containing the discount.
- 5.2. Complaints should be submitted by email to **biuro@jmj.krakow.pl** or by post to the Organizer's registered office address.
- 5.3. The Organizer will review the complaint within 14 working days of its receipt.

### 6. Termination of the Promotion

- 6.1. The Organizer reserves the right to modify the terms of the Promotion or terminate it before its scheduled end date if unforeseen circumstances occur. In such a case, the Organizer will promptly inform participants.
- 6.2. In the event of early termination of the Promotion, discounts will apply only to agreements signed before the date of termination.

#### 7. Personal Data Protection

- 7.1. By participating in the Promotion, participants consent to the processing of their personal data by the Organizer for the purpose of carrying out the Promotion.
- 7.2. Participants' personal data will be processed in accordance with the Organizer's privacy policy available on the website [link to the privacy policy].
- 7.3. Participants have the right to access their personal data and to correct them.
