

## **Terms and Conditions of the "Spring Promotion"**

### **1. General Provisions**

1.1. The organizer of the "Spring Promotion" (hereinafter referred to as the "Promotion") is the ACCOUNTING OFFICE "JMJ" S.C. JADWIGA LEŚ-MALEC, JACEK NOGIEĆ, located at Rydlówka 42a/2, 30-363 Kraków, NIP: 6772176541, REGON: 356319906 (hereinafter referred to as the "Organizer").

1.2. The Promotion is valid from April 1 to June 30, 2025, unless the Organizer decides to end or extend it earlier.

1.3. The Terms and Conditions set forth the rules, participation conditions, and rules for granting discounts within the Promotion.

### **2. Participation Conditions**

2.1. A participant in the Promotion can be any natural person, legal person, or organizational unit without legal personality, who enters into an agreement for accounting services with the Organizer during the Promotion period.

2.2. The Promotion is intended for new clients and current clients who recommend the service to new clients.

2.3. Participation in the Promotion is voluntary and does not require the purchase of other services than those covered by the Promotion.

### **3. Rules for Granting Discounts**

#### **3.1. New Clients**

New clients who sign an agreement for accounting services between March 1 and May 31, 2026, will receive the following discounts on accounting services:

- 30% discount on maintaining the tax revenue and expenditure ledger and income records,
- 30% discount on full accounting services.

#### **3.2. Referring Clients**

Current clients who recommend the accounting service to a new client will receive the following discounts on accounting services:

- 20% discount on maintaining the tax revenue and expenditure ledger and income records,
- 20% discount on full accounting services.

3.3. The discounts will be valid for 3 months, starting from the date the Organizer begins providing accounting services based on the signed agreement.

3.4. The discounts will be applied by reducing the invoice value for the provided accounting services.

## **4. Limitations**

- 4.1. The Promotion cannot be combined with other promotions organized by the Organizer.
- 4.2. The Promotion applies only to new agreements signed during the promotion period (from March 1 and May 31, 2026).
- 4.3. The discounts granted as part of the Promotion cannot be exchanged for cash or transferred to other individuals

## **5. Complaints**

- 5.1. Participants in the Promotion have the right to submit complaints regarding the justification of the discount within 14 days from the date of receiving the invoice with the discount.
- 5.2. Complaints should be submitted to the email address: [biuro@jnj.krakow.pl](mailto:biuro@jnj.krakow.pl) or the Organizer's office address.
- 5.3. The Organizer will review the complaint within 14 business days from its receipt.

## **6. Termination of the Promotion**

- 6.1. The Organizer reserves the right to change the terms of the Promotion or terminate it before the specified date in the event of unforeseen circumstances, and will immediately inform the Promotion participants.
- 6.2. In the event of early termination of the Promotion, the discounts will only apply to agreements signed up to the termination date of the Promotion.

## **7. Data Protection**

- 7.1. Participants in the Promotion consent to the processing of their personal data by the Organizer for the purposes of executing the Promotion.
- 7.2. Personal data of the participants will be processed in accordance with the Organizer's privacy policy, available on the website <https://jnj.krakow.pl/privacy-policy.pdf>.
- 7.3. Participants have the right to access their personal data and correct it.

## **8. Final Provisions**

- 8.1. In matters not regulated by these Terms and Conditions, the provisions of civil law, in particular the Civil Code, shall apply.
